3. EVENT VENUE

The Venue – Ahumada Waterski (Lago Ahumada)

The competition will take place at Ahumada Waterski, an artificial lake purpose-built for waterskiing, measuring 710 meters in length and **80–92 meters** in width. It is located in the heart of the Traslasierra Valley, between the towns of San José and Villa Dolores, Córdoba Province.

- Chile–Argentina binational competition.
- Several rounds of the Argentinian Waterski Championship.

WEATHER

Villa Dolores has a warm, mostly dry climate, with more than 300 sunny days per year. In March, daytime temperatures are warm (avg. 28 °C) and nights are mild (18 °C). We recommend light clothing for the day and a layer for the evening. This period coincides with late summer in Argentina, with a very low chance of rain.

7.2 **VISA**

Visa requirements for entry into Argentina

More than 120 nationalities do not require a tourist visa to enter Argentina. To confirm your status and view official details:

- Countries exempt from visa official list
- Visa application requirements and process

Please check passport validity and any additional requirements (e.g., consular fees or invitation letter) with the relevant Argentine consulate well in advance.

7.3 **Airport**

Primary – Córdoba (COR)

The Ingeniero Ambrosio L. V. Taravella International Airport (COR) — "Pajas Blancas"— is the main air hub in Argentina's interior and one of the busiest in the country. Modern and easy to navigate, it lies ~200 km from Lago Ahumada (≈ 3 hours by car). Part of the drive crosses the Camino de las Altas Cumbres, one of Argentina's most spectacular scenic roads; on clear days it's common to spot **Andean condors** soaring over the valleys and cliffs along the route.

8.3 **Car Rentals**



The IWWF Bye-Law 16.1 states:

It is the responsibility of each Federation when entering competitors for a World Titled Event to ensure that its competitors are adequately insured for personal accident, permanent disabilities, death and medical expenses.

12. **EVENT RULES**

All Federations, team managers, team captains and riders should be familiar with the current IWWF World Waterski Rules.

13. **ENTRY FEE**

The Entry Fee for the 2026 IWWF World Under 17 Waterski Championships will be US\$330.00 per competitor regardless of discipline. The Entry Fee includes transportation from the Official Hotel to the Site, Lunch on Site on competition days and a Final Night Banquet Ticket (to include one team official).

Entry Fee payments 13.1

Payments of the Entry Fees must be made at the time of athlete registration by bank transfer to the bank account mentioned in item 14 below. Once payment is made, please mail your proof of payment to: clubdeesquinautico@gmail.com. Remitting parties are responsible for ALL bank charges at both ends. Where bank charges have been deducted, Federations/Skiers will be required to make good any shortfall at registration.

ENTRY AND ADMINISTRATION

14.12: Entry and Administration

Each Federation shall declare, through EMS, not later than 75 days before the scheduled start of the first event of the IWWF World Championships:

- The names of the members of its team
- The names of the competitors entered as "Individuals"
- The names of the competitors entered as Wild Cards
- The names of the Official reserves.

For each competitor registered, the events that they will compete in together with the ramp height for Jump need to be entered.

An entry is considered complete when the Skier's name is registered in EMS and the full Entry Fee Payment has been received.

All payments need to be made by **Bank Transfer**. For the Official Reserves, no payment is due at this time.

Any skier entered as a Wild Card or Individual is also to be considered to be a TEAM reserve.

An entered skier may be replaced by a different one without penalty, provided that they have already been entered as a Reserve skier, wild card or individual.





















The 75 days deadline does not include those skiers who may additionally qualify as individuals through the Weekly or the Pro Ranking List (If applicable). For those skiers the following deadlines apply:

The deadline to enter skiers who qualify under the Weekly Ranking List is 30 days before the Championships.

Fines for Late Registration.

Any Federation not meeting the registration deadlines will not be allowed to compete until their Federation pays a fine to the IWWF Representative at the Championships. The fines are as follows:

- US\$25 per skier if the registration is made between 74 and 60 days before the scheduled start of the first event of the World Championships
- US\$50 per skier if the registration is made between 59 and 45 days before the scheduled start of the first event of the World Championships
- US\$75 per skier if the registration is made between 44 to 30 days before the scheduled start of the first event of the World Championships
- US\$100 per skier if the registration is made between 29 to 15 days before the scheduled start of the first event of the World Championships
- Double the Entry Fee per skier if the registration is made between 14 days until 12:00 (competition local time), 2 days before the scheduled start of the first event of the World Championships

Example: scheduled start of the first event of the World Championships is July 31 deadline to register skier is noon 12:00 UTC of July 29.

Two days before the start of the first event the entry lists shall be closed at noon 12:00 (competition local time) and thereafter the order of competitors entered and paid will be finalised and posted.

The Scorer in consultation with the Chief Judge should post Preliminary Running Orders 7 days preceding the start of events with the orders clearly marked as "Preliminary and subject to change". No change in this order is allowed after noon (competition local time) of the two days preceding the start of events except that a team representative may without penalty:

- 1) Withdraw a skier from the competition.
- 2) Replace an injured skier with a qualified official reserve from the same team with the authority of the Chief Judge and before the start of the first event, that is, before the first skier taking part in the first event has started.
- The substitute skier shall start first in the series in which he is qualified unless the draw has not vet been completed.
- Team or individual athletes not showing up:

In the event a team or individual athletes (for whom their Federation has submitted a competition entry), fail to show up for a competition, their entry fee shall still be payable in full, unless a valid written excuse is received by 12 noon of two days before the start of the competition.

A valid excuse may include a sickness certificate or a certificated injury and should be considered and agreed as valid by the IWWF Representative at the Championships. All fines have to be paid on-site to the IWWF Representative at the Championships. No skiers will be allowed to start if any due fine is not paid.





















If the "valid excuse" is accepted, the money will be refunded by the Organiser to the relative Federation, within 30 days after the end of the competition.

14.07: Site Familiarisation

The last two or three days immediately before the Championships will be reserved and used for Official Familiarisation. This will be organised so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarisation.

Slalom skiers will receive -4 passes or 6 minutes whichever is less Tricks skiers will receive 2 passes or 5 minutes whichever is less Jump skiers will receive 3 passes or 6 minutes whichever is les

60 days before the Championships each entered competitor will be allocated Official Familiarisation time as specified above. 45 days before the scheduled start of the event, the Organiser (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarisation schedule (including the allowed time).

If a Federation does not want to take part in the Official Familiarisation, it must notify the Organisers and the Chief Judge as soon as possible.

The order for familiarization will be based on the team results from the previous IWWF World Championships with the last placed team athletes going first, and shall be grouped by event, i.e., slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together. Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

The Chief Judge shall have the discretion to change the start time of team's familiarisation based on extraordinary circumstances. During the Official Familiarisation period the Chief Judge may allocate any available site familiarisation times but only to skiers who have not already used it or do not have time allocated.

The cost per hour for Official Familiarisation is US\$30.00 per set / US\$330.00 per hour.


